Amendments to Governor Gianforte's 2025 Biennium Executive Budget

In accordance with 17-7-112, MCA, I am submitting the following formal written amendments to my November 15 preliminary 2025 biennium Executive Budget. The changes are broken out between substantive changes, technical corrections, and narrative updates. Most, if not all, of these changes have already been discussed with your staff. In fact, many of the technical and narrative changes came at the request of your staff. Changes are reflected in the H02 version in IBARS.

Substantive Changes

- Department of Public Health and Human Services (DPHHS): Removed a duplicate change package totaling \$12.2 million federal funds for Change Package (CP) 11888 Medicaid Expansion HUF.
- Department of Public Health and Human Services: Corrected an error in the base budget in the Health Resources Division. The funding was mistakenly placed in the budget for the Big Sky RX program and was moved to the Medicaid Core program. This resulted in a reduction of required funding in CP 11991 of \$9.3 million general fund and \$16.7 million federal funds each year of the biennium.
- Department of Public Health and Human Services: CP 11888 advertently contained duplicate funding in two reporting levels. The duplicate funding was removed reducing the request by \$4 million in FY 2024 and \$8 million in FY 2025 federal funds.
- Department of Administration: CP 702 requesting \$170,000 each year for IT security consolidation training costs was added.
- Department of Revenue: CP 18 was adjusted to add 0.25 FTE to make a 0.75 FTE position a full-time position in the Alcoholic Beverage Control Division.
- Office of Commissioner of Higher Education: Duplicate funding for Legislative Audit costs was removed from CP 902 reducing the request by approximately \$600,000.
- Department of Justice: Two change packages were added requesting 3.00 FTE trainers at the Montana Law Enforcement Academy and 1.00 FTE appellate attorney in the Legal Services Division.

- Department of Military Affairs: CP 2106 was added to request funding for operation of the Disaster Warehouse and Logistic Operations.
- Office of Public Instruction: The executive budget includes proposed legislation to move the deposit of the statewide 95 property tax mills from the general fund to the guarantee account. Associated with this legislation is a change package to remove the expenditure of these funds from HB 2 as the guarantee account, the first source of funding for K-12 education, is statutorily appropriated.
- Office of Public Instruction: An adjustment was made to the change package for guaranteed tax base (GTB) funding based on revised revenue estimates.
- Montana State Library: A state special revenue change package was added to provide start-up funding for the Real Time Network.
- Montana Historical Society (MHS): A state special revenue change package was added to allow the MHS to spend funds previously transferred to the agency from the Legislative Services Division for archiving legislative proceedings.

Technical Corrections

- Standard HB 2 language for the Board of Crime Control to continue the balance of grant appropriations into the next biennium was added.
- Funding was adjusted for the Legislative Audit appropriation in the Department of Military Affairs.
- Standard HB 2 language for the Department of Public Health and Human Services (DPHHS) related to the Montana Telecommunications Access Program was added.
- Funding was moved for the Legislative Audit appropriation for DPHHS to the correct program
- Funding for the Legislative Audit appropriation in the Department of Agriculture was adjusted to account for proprietary funding.
- In the Department of Justice, funding for CP 502 was adjusted from general fund to state special revenue.
- In the Office of Commissioner of Higher Education (OCHE), CP 405 was corrected to reflect it is not a one-time-only proposal.
- In the Montana School for the Deaf and Blind, CP 8 and 12 were corrected to reflect the requests are not one-time-only.
- In the Department of Revenue, the language related to required transfers for cannabis revenue was updated based upon the most recent revenue estimates.
- CP 13, 15, and 16 in the Department of Revenue were updated to indicate they are onetime-only requests.
- Funding for the Legislative Audit in the Department of Military Affairs was updated.
- Change packages 350108, 35109, and 350111 in the Department of Natural Resources and Conservation were removed as they are included in HB 5. CP 316 in the Department of Transportation was removed for the same reason.
- Duplicative funding in the Department of Military Affairs was removed in CP 3103 and 3104.
- In the Department of Administration, CP 2101 was removed as it was not needed. In CP 101, the funding was moved from HB 2 to proprietary funds correcting an error. CP 108 was adjusted for the same reason.

- An adjustment was made in the Department of Administration to correctly allocate a position between Treasury and Warrant Writer.
- In the Department of Corrections, change packages for the ongoing provider rate increases was adjusted to correct a mathematical error.
- Funding for SWPL 1 in the Workforce Development Division (OCHE) was changed from general fund to federal funds.
- Changes to the FTE types in CP 9 for the Office of Public Defender were made to accurately reflect the positions requested.
- In the Department of Commerce, state special revenue was adjusted in CP 5109 for the Business Attraction program.
- An adjustment was made between first level expenditure categories in CP 51506 for the Montana State Library.
- Funding in CP 605 and 612 in the Office of Public Instruction was moved between federal funds.
- Federal funds were adjusted between CP 11017 and CP 11015 in DPHHS.
